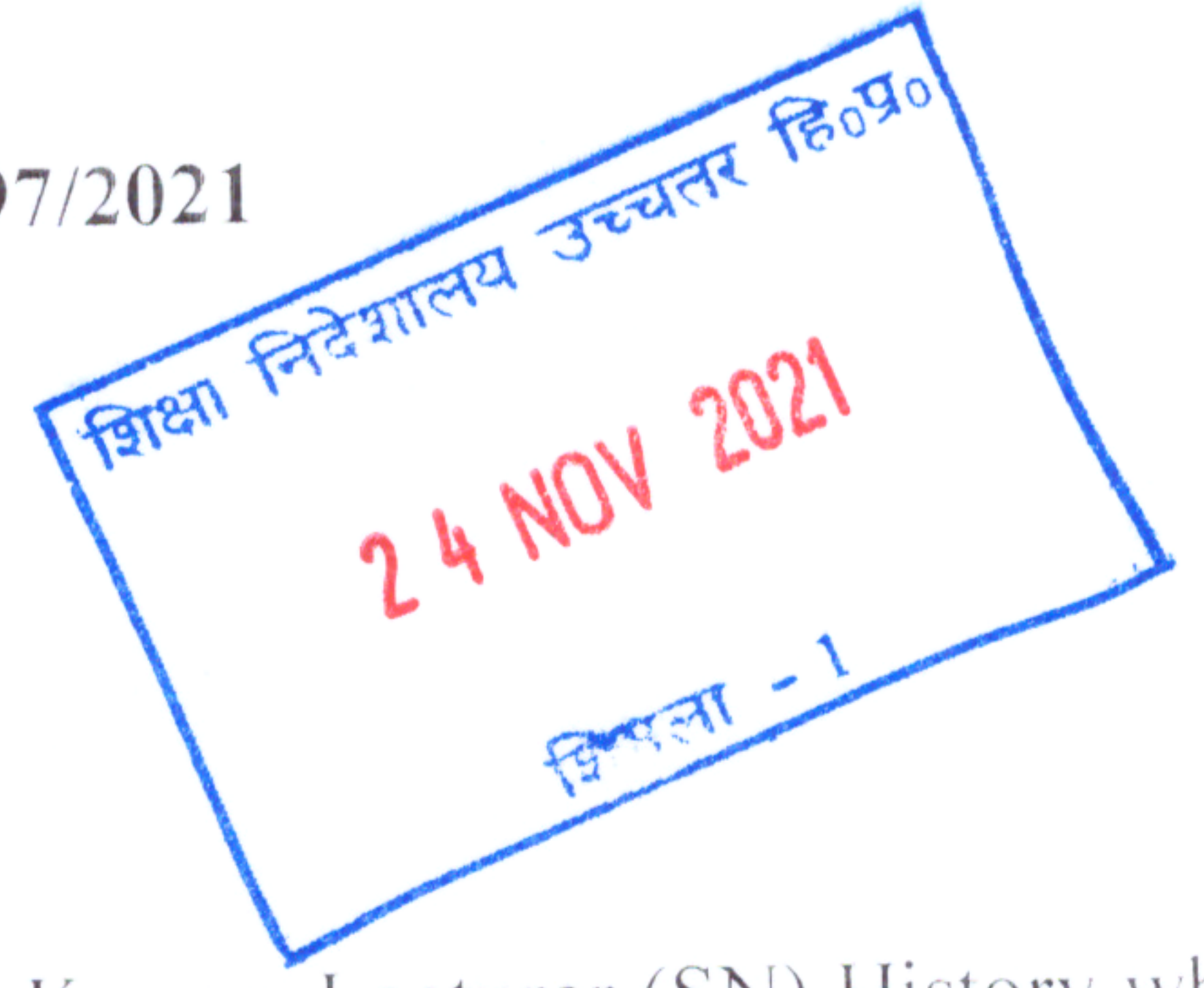

**ORDER**

Whereas, the petitioner namely Sh.Ashok Kumar, Lecturer (SN) History who is working at GSSS Thachi (Mnd) w.e.f. 01.04.2017 has filed CWP No. 1688/2021 titled as Ashok Kumar Vs State of HP before the Hon'ble High Court seeking there in relief regarding his transfer after completion of his stay. This petition was listed on dt. 27.10.2021 when the Hon'ble Court has given following directions:-

“Accordingly, the instant writ petition is disposed of with a direction to the petitioner to file a representation before the respondents clearly setting out there in five stations of his choice, out of which one essentially shall be out of his home district. In the event of such representation being made within one week, the respondents shall consider and decide the same and thereafter issue consequential orders of transfer of the petitioner to any one of the stations as given in the representation within a period of three weeks, without insisting upon condition of reliever. Pending applications, if any, also stands disposed of.

And whereas, upon passing of above direction the representation from the petitioner has been received on 08.11.2021 and he opted six stations for his transfer against the incumbents working there which cannot be considered as it will lead another litigation. He has not opted any available vacancies. However one of the station opted by him i.e GSSS Kothi, Distt. Bilaspur will be vacated on 02.02.2022 due to retirement of present incumbent on 31.01.2022.

And whereas, as per the direction passed by the Hon'ble Court as above, the request of the petitioner is being allowed/considered to GSSS Kothi, Distt. Bilaspur against vacancy being caused due to retirement of present incumbent on 31.01.2022.

Now therefore, after taking into account the above discussed facts and circumstances of the case, request of the petitioner has been considered and he is hereby transferred to GSSS Kothi, Distt. Bilaspur against vacancy being caused due to retirement of present incumbent on 31.01.2022 without TTA/JT. These orders shall come into force on or after 01.02.2022 and till then the petitioner Sh. Ashok Kumar, Lect(History) will continue at GSSS Thachi, Distt. Mandi. Representation is hereby disposed of.
