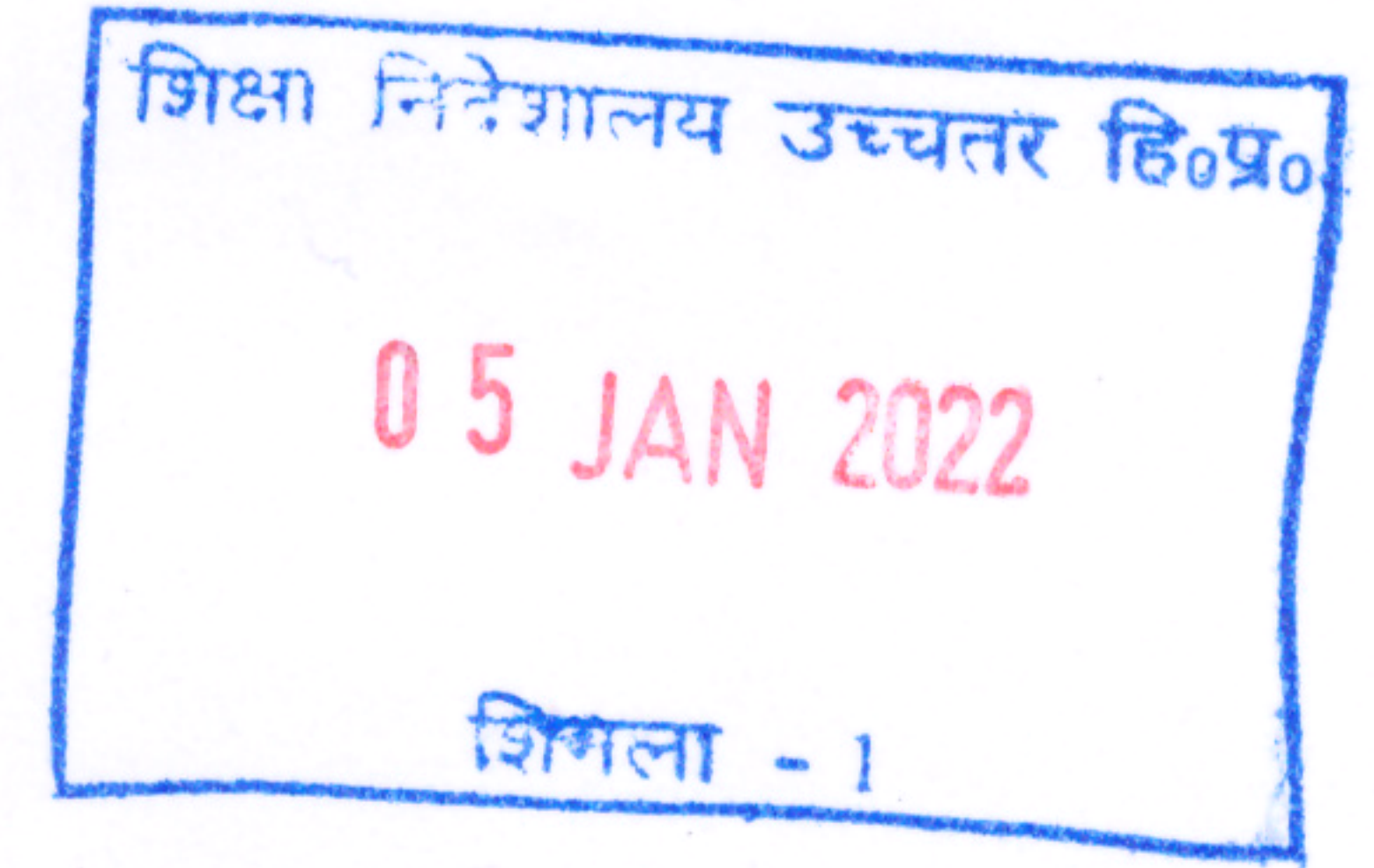




OFFICE ORDER
