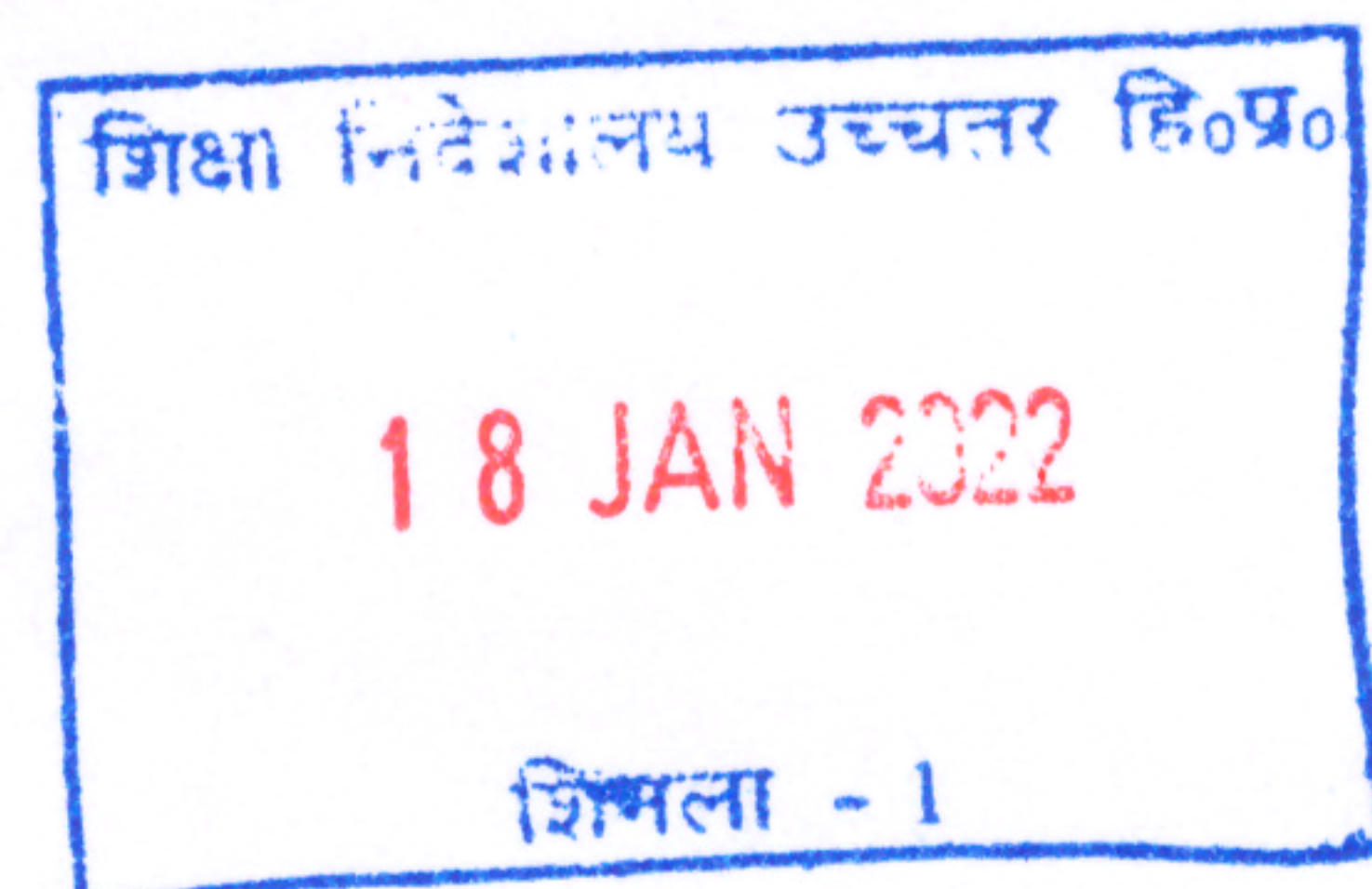


OFFICE ORDER
