On the above cited subject, it is to bring to your notice that instead of repeated reminders through print and electronic media as well as directions given by the Department of Higher Education, H.P. for seeding of Aadhaar number with Saving Bank account of the students for the year 2021-22 (Renewal) under Post-Matric Scholarship Scheme for OBC Students. Many (6) times opportunities have been provided to the concerned students for seeding the aadhaar number with their bank account number.

There is a difference between linking and seeding of aadhaar number with bank account. It is directed to confirm from the concerned bank branch whether their banks account number is seeded with aadhaar or not for getting the scholarship amount through Direct benefit Transfer mode as per direction given by the Government of India. Proof regarding seeding of Bank account with Aadhaar may be sent through e-mail. This matter is also viewed seriously by the Hon'ble High Court of Himachal Pradesh.
