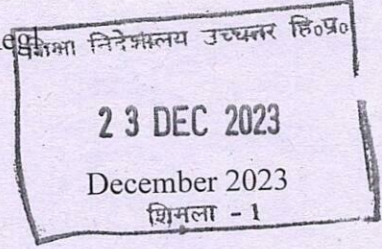

### OFFICE ORDER

The Petitioners were initially engaged as DPEs as per the GIA to PTA Rules, 2006 during the year 2006 onwards. Thereafter, the Government of H.P. took a conscious decision to bring the services of PTA (GIA) provided teachers on contract basis vide Notification No. EDN-A-Kha(7)6/2012 dated 16.08.2013. However, the decision of Government to bring the services of PTA (GIA) teachers on contract basis was challenged by Sh. Pankaj Kumar by filing CWP No.6916 of 2011 in the Hon'ble High Court of H.P. which was decided on 09.12.2014 in favour of PTA(GIA) contract teachers and accordingly the services of PTA (GIA) provided Teachers were taken over on contract basis in January, 2015. In the meantime, the decision of Hon'ble High Court of H.P. dated 09.12.2014 was further agitated before the Hon'ble Apex Court of India by way of filing SLP No. 1426/2015 titled Pankaj Kumar & connected matters and Hon'ble Apex Court ordered on dated 22.01.2015 that "Status quo be maintained till orders to the contrary". Similarly, the Orders dated 09.12.2014 in CWP No. 7728/2013 titled Shiksha Mankotia & Ors Vs State (clubbed with 6916/2011) were also challenged by Smt. Kushal Kumari and another in SLP No. 7709/2015 wherein the Hon'ble Supreme Court passed interim order on 09.03.2015 that "Status quo be maintained till orders to the contrary". The SLP No.s 6644/15, 6090/2015 and 7709/2015 were converted into Civil Appeals bearing CA No. 2813/2017, 2814/2017 and 2815/2017 and same were dismissed by the Hon'ble Supreme Court on dated 17.04.2020.

After dismissal of the said SLPs/ Civil Appeals, the Government conveyed approval vide letter No. EDN-A-Kha(7)06/2012-Loose-I dated 05.08.2020 to regularize the services of GIA to PTA provided teachers taken over on contract basis, as well as left out GIA to PTA provided teachers whose services were not taken/brought on contract basis earlier due to various reasons, with immediate effect. After the Govt. approval, bio-data of PTA (GIA) contract teachers as well as left out PTA (GIA) Teachers was collected and after

observing all codal formalities, regularization orders were issued vide office order No. EDN-HE(12)B(2)-17/2012-PTA dated 07.08.2020, subject to final outcome of the CWP No. 2850/2020 titled Pawan Kumar and ors. Vs State of HP. Feeling aggrieved, the PTA (GIA) teachers filed CWP No 342/2021 titled as Yashwant Singh & Ors Vs State of HP before the Hon'ble High Court to regularize their services w.e.f. 01.04.2018 at par with the teachers who were appointed in the Department through direct recruitment and completed 3 years contractual service as on 31.03.2018 and the Hon'ble High Court allowed the said CWP vide its Order dated 31.08.2022.

The matter of regularization of services of PTA (GIA) Teachers as per the judgment dated 31-08-2022 was taken up with the Govt. for approval to regularize their services accordingly w.e.f. 01-04-2018. The Govt. however had directed to file SLP in the matter before the Hon'ble Supreme Court of India. The State has filed SLP(C) No 6966/2023, which was listed on 24.04.2023 and on that day the same was dismissed. Thereafter, the petitioners filed Ex. Pet. No 86/2023 to execute the order dated 31.08.2022 passed by the High Court. The matter was taken up with the Govt. for necessary directions regarding benefit of regularization of services w.e.f. 01.04.2018 along with all consequential benefits vide letter No. EDN-HE(19)B(1)-2/2012-PTA-CC dated 31.05.2023 in which the Government vide letter No. EDUA-E005/4/2023-EDU-A dated 02.09.2023 conveyed its approval to regularize the services of the petitioners in CWP No. 342/2021 and clubbed petitions (with this CWP and with Execution petition No. 86/2023) w.e.f. 01.04.2018. Further, vide letter No. EDUA-E005/4/2023-EDU-A dated 04-12-2023 it has been directed "to implement the cases of GIA to PTA provided Teachers, similarly situated to the judgment passed by the Hon'ble High Court in Ex. Pet. No. 86/2023 in CWP No. 342/2021 titled as Yashwant Singh and others without referring such cases to the Govt."

In view of the facts and circumstances as narrated above and as directed by the Govt./AD in compliance to the Hon'ble High Court Orders, its vide letter No. EDUA-E005/4/2023-EDU-A dated 02-09-2023, and letter No. EDUA-E005/4/2023-EDU-A dated 04-12-2023, the following Petitioners /DPEs in CWP No. 342/2021 (and clubbed matters) whose services were taken on contract basis in Jan.,2015 and their services were regularized vide

Office Order No. EDN-HE(12)B(2)-17/2019-PTA dated 21.08.2020 are now hereby regularized w.e.f. 01.04.2018 with all consequential benefits. The consequential monetary benefits to the petitioners will be released as per Hon'ble Court Order dated 13.09.2023 in Ex. Pet No 86/2023 i.e. 40% of arrears payable according to pre-revised scale may be paid by 31.12.2023 and remaining 60% arrears in two equal annual installments may be paid by 31.12.2024 and 31.12.2025 by calculating difference of pay of the petitioners on the basis of pre-revised pay scale for the period from 01.04.2018 till the earlier date of regularization. It is further directed that arrears on the basis of revision of pay scale shall be paid, as per the instructions issued by the Finance Department, H.P. letter No. Fin-E-I-C(17)-6/08 dated 07.01.2012 and vide letter No. Fin-(PR)B(7)-1/2021-Loose dated 17.09.2022.
