Sir,

In continuation of this Directorate letter of even number dated 21-02-2023 and 01-03-23, on the above cited subject. As, you are aware that last date for the registration of students under various centre and state sponsored scholarship schemes was fixed on 03-03-23. In this context, all the Heads Government & Private Educational Institutions (within and outside of Himachal Pradesh where Himachali bonafide students are studying and who are claiming scholarship from the State Government) are requested to ensure the following:-

- 1. The Head of the Educational Institution and Nodal Officer of the concerned Educational Institution will ensure to verify / re-verify (as the case may be) all scholarship applications of the students under centre and state sponsored scholarship scheme on or before 07-03-23, positively. No scholarship applications must be remained in the Login ID of the Educational Institution for verification.
- 1. The Head of the Educational Institution and Nodal Officer Scholarship of the concerned Educational Institution will ensure to provide the list of students who has left the Educational Institution (who have applied for scholarship under centre or state sponsored scholarship scheme) to this Directorate on or before 12-03-2023, through email ID:-nsphpsml@gmail.com as well as intimation of such information on Telephone No.0177-2656622.
- 3. Scheme wise and Institution(s) wise verified lists of students under Centre and State sponsored Post-Matric Scholarship Schemes for the Academic year 2022-23, alongwith course wise Government approved fee structure, approval of the

competent authorities of all the Courses, Intake of Seats etc., may be provided to this Directorate on or before 13-03-23.

- 4. Scheme wise & Course wise Affidavits for the Academic Year 2022-23 on behalf of Vice-Chancellor/ Registrar/ Principal of respective University/ Educational Institution, which must be attested by the 1st Class Magistrate may also be provided to this Directorate on or before 13-03-23. The specimen copy of affidavit is already uploaded on the Departmental website of Higher Education, Himachal Pradesh.
- 5. In the case of Pre-Matric Scholarship Schemes, the Deputy Director of Higher Education of the concerned District will submit scheme wise undertaking to this effect that complete scholarship applications in all respect after checking the eligibility credentials such as self attested Caste Certificate, Income Certificate of the Parents, Bonafide / Domicile Certificate, Latest Mark-sheets of previous class has been checked and verified on the National Scholarship Portal as per the scheme guidelines under Pre-Matric Scholarship Scheme.
