ORDER

Whereas, the petitioner Sh. Sikander Singh, Lect(SN)Hindi who was transferred from GSSS Killar (Pangi) to GSSS Manhuta (Chamba) against vacancy and in his place Sh. Raj Kumar, Lect(Hindi) was transferred from GSSS Hillour(Chamba) on dated 27.09.2023. Against these orders he has filed the CWP No. 7279/2023 before the Hon'ble High Court and the same was disposed of on dated 04.10.2023 with the direction that he may represent his case before the respondent No. 2 Director Higher Education praying therein to post him at one of the station of his choice which in turn shall be decided by the competent authority.

And whereas, upon passing of above direction the representation from the petitioner has been received vide which he has requested that he already served in hard and tribal area more than normal tenure and he was transferred to GSSS Manhuta (Chamba) which is very far from his home station. Hence, he may be adjusted in choice of his stations as under:-

1. GSSS Hillour (Pangi) (Chamba)
2. GSSS(G) Chamba
3. GSSS(B) Chamba
4. GSSS Dhalpur (Chamba)
5. GSSS Sach(Chamba)

And whereas, as per the direction passed by the Hon'ble Court as above, request of the petitioner has been considered and found that as the petitioner has opted five stations of his choice for his adjustment against the incumbents working there which cannot be considered as it will lead another litigation. However, one of the station opted by him i.e. GSSS Hillour(Chamba) can be considered on consent basis. As the incumbent i.e Sh. Raj Kumar, Lect.(Hindi) is working there w.e.f. 08.09.2017 has already completed the normal tenure. Hence, request of the petitioner is being allowed/considered.

Now therefore, after taking into account the above facts and circumstances of the case, request of the petitioner has been considered and the petitioner Sh. Sikander Singh, Lect(Hindi) who is u/t from GSSS Killar (Pangi) (Chamba) to GSSS Manhuta (Chamba) is hereby adjusted at GSSS Hillour(Chamba) vice Sh. Raj Kumar, Lect(Hindi) and vice versa without TTA/JT.

With these observations, representation stands disposed of.
