## **ORDER**

Whereas, the petitioner namely Smt. Sunita Kumari, Lecturer (SN) History who is working at GSSS kathiana (Hamirpur) w.e.f. 11.10.2022, has filed CWP No. 16558/2024 titled as Sunita Kumari vs State of HP before the Hon'ble High Court seeking there in relief regarding her transfer on medical grounds. This petition was listed on 30.12.2024 when the Hon'ble Court has given following directions:-

"Looking to the projected grievance of the petitioner, this writ petition is disposed of by directing respondent No.2 to consider and decide the aforesaid representation of the petitioner, in accordance with law, after ascertaining the factual positon and keeping in view the applicable transfer policy with all its amendments, within four week. The order so passed be also communicated to the petitioner. Pending miscellaneous application(s), if any shall also stand disposed of."

And whereas, in compliance of Hon'ble High Court order dated 30.12.2024 the petitioner was called for personal hearing on 16.01.2025 and she was heard in person. During the course of hearing she has requested that her health condition is not good. Hence, she may transferred either to G(G)SSS Hamirpur/ GSSS Kot (Hamirpur) or GSSS Mathani (Hamirpur) against longer stay or by clubbing there stay within radius 20 of Km.

And whereas, as per the direction passed by the Hon'ble Court as above, the request of the petitioner has been considered and found that as on now there is no vacancy of her choice and her request against longer stay cannot be considered during the ban on transfer as it will lead another litigation. However, keeping her medical condition, her request will be considered as and when the ban on transfer will be lifted.

Now therefore, after taking into account the above discussed detailed facts and circumstances. The request of the petitioner connot be acceded to. Hence representation has been considered and rejected. Accordingly, petitioner will be continue at her present place of posting, representation stands disposed of.
