## General Guidelines for Awarding the SVP 2021-22 winners Schools at the District Level

- 1. It is a commendable effort that schools across districts have active participation in the Online submission of applications for the SVP 2021-22. As you are aware that we have now entered into the next stage of the award process Selection of schools for the awards at the district level through the qualitative physical verification by the trained evaluators (in accordance with the guideline issued by the Ministry of Education dated April 4, 2020, through letter No.F.27- 18/2019-IS-9/ IS- 6).
- In this respect, it is to be noted that the district must complete the quality physical verification of the eligible schools (3 Star and above), by the given deadline of District level Award selection (i.e., May 15, 2022) to finalize the District Level Award Winning schools (total of 38 as per SVP guideline)
- 3. As one of the key objectives, of Swachh Vidyalaya Puraskar is to recognize, inspire and celebrate excellence in sanitation and hygiene, after the finalization of the schools at the district level, each of the selected schools in the overall score category (total 8 max.) and each of the schools having the highest score under each sub-category (total 30 max.) are to be awarded at the district level.
- 4. It is requested that the District Collector & District Committee should felicitate the winners in a district-level function organized exclusively for Swachh Vidyalaya 2021-22, just after completion of Final Award selection at the district level. This District level Award ceremony is ideally expected to be completed by June 30, 2022 (with a maximum of 10 days of flexibility in exceptional unavoidable cases).
- 5. This ceremony may be organized at the Conference Hall of the District Collectorate/ District Panchayat or any other suitable location as appropriate.
- SVP 2021-22 District Panel can be used for downloading the generated certificates for the award-winning schools for respective categories.
- 7. Key invitees for the District Level Award Felicitation ceremony should primarily include the head of the award-winning schools (38), active child cabinet members, active SMC representatives, district committee members, all evaluators (as possible), honourable public representatives, eminent personalities, Civil Society Organisation (CSOs)& other invitees as deemed necessary by the district.
- District Level Award ceremony must be attended by district level officials from Health, Women &Child Development, Public Health Engineering/ Water & Sanitation, Social Justice & Empowerment, Panchayati Raj & Rural Development, Urban Development, Renewable energy Department, Irrigation Department etc.
- 9. The agenda of the district level award felicitation ceremony can include the following (while the district may add topics, as required/ relevant):
  - Address by key speakers
  - Motivational speeches by eminent personalities, speakers
  - Speech by a few selected school representatives about the special unique feature of their SVP
  - > The vision of Clean, hygienic, infection-free, safe, healthy, child-friendly, climate-smart school\*

- Swachh Vidyalaya Puraskar as means to promote School Level Swachhata Action Plan for sustaining improved Water Sanitation & Hygiene (WASH) in Schools (With a message that every school should aspire for V STAR clean school)
- > Brief guidance/ sharing by the concerned department officials about the related programmes & convergence opportunities for school
- Actual Award Felicitation to the award-winning Schools
- ➤ Use of appropriate IEC Audio-Video messages
- 10. The district-level Award ceremony should be extensively highlighted in the respective local Newspapers print media, electronic media, social media to promote the key messages of the vision of the clean school with the need of sustaining adherence to Swachh Vidyalaya Priorities.
- 11.
