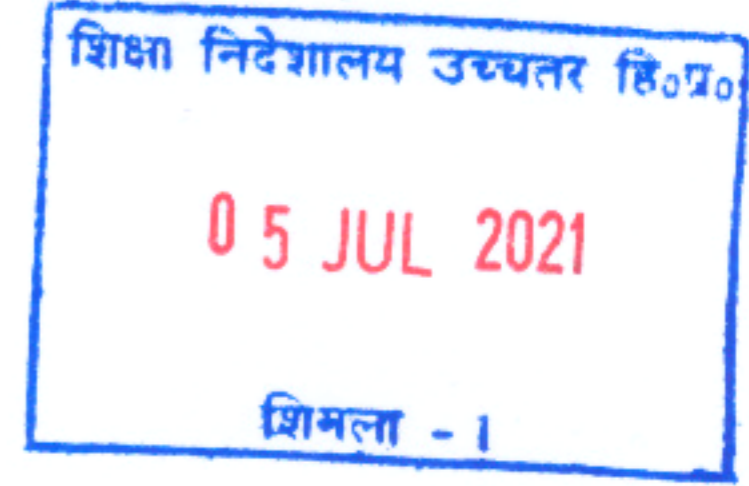

ORDER

Whereas the petitioner namely Sh. Tanzin Dandup, Lect(History) was transferred from GSSS Giaboung (Knr) to GSSS Deori-Khaneti(Sml) on dated 06.04.2021. Feeling aggrieved against these orders he filed CWP No. 2998/2021 titled as Tanzin Dandup vs State of HP before the Hon'ble High Court seeking there in relief, which was listed on dated 18.05.2021 when it was directed that:-


"Consequently, this petition is disposed of with liberty to the petitioner to make representation to the respondent/ competent authority within two weeks. On receipt of such representation, the said respondent/ competent authority shall decide the same in the light of the transfer policy occupying the field particularly Clauses 5.5 and 16.1 thereof. Within four weeks thereafter. Till decision of the representation, office order dated 06.04.2021, shall remain stayed.

And whereas, upon passing of above direction the representation from the petitioner through Advocate has been received dated 16.06.2021 and he has requested that he may either be retained in GSSS Giaboung (Knr) or may be adjusted at GSSS Rampur, GSSS Lalpani (Sml) or GSSS Solan in Solan Distt. The petitioner cannot be retained at GSSS Giaboung(Knr) as he has already completed his normal stay and has been transferred with the prior approval of competent authority and cannot be adjusted in other institutions opted by him due to no vacancy. Hence, he has been again directed to give fresh option against any vacancies but he has not given any option.

And whereas, as per the direction passed by the Hon'ble Court, above the request of petitioner has been considered and found that since he has already completed his normal stay at GSSS Giaboung (Knr) and now he should serve in GSSS Deori-Khaneti (Sml). As, if he can serve in GSSS Rampur/Lalpani or GSSS Solan (Sml) which he opted, than he definitely can serve at GSSS Deori-Khaneti(Sml). Moreover, concession in 5.5 clause of transfer policy is applicable for Class-III and Class-IV officials, where as the petitioner is class-II employee.

Now therefore, after taking into account the above discussed detailed facts and circumstances, transfer order of the petitioner issued vide this Directorate office order No. EDN-H(26)B(6)1/2021-History dated 06.04.2021 shall stand and he is hereby directed to join at GSSS Deori-Khaneti (Sml). Representation is hereby disposed of


