ORDER



Whereas, Sh.Revati Ram, Lecturer (School-New) (Geography) was transferred from GSSS Manali (KLU) to GSSS Milah (SMR) on administrative grounds vide office order dated 21.05.2021. Sh.Revati Ram challenged these orders by filing CWP No. 3098/2021 before the Hon'ble High Court. The case was listed before Hon'ble court on 28.05.2021 when the same was disposed of with the following directions:-

“In view of the afore prayer made on behalf of the petitioner, without going into the merits of the case, present petition is disposed of with a direction to the petitioner to file a representation, ventilating his grievances therein, to respondent No. 2, within a period of one week, which shall be decided by said respondent, within a period of four weeks, thereafter. Obviously, in the afore process, the writ petition shall be personally heard and the representation shall be decided within the afore stipulated period, in light of the Comprehensive Guiding Principles-2013. Till the decision of the representation, if any, made by the petitioner, operation and execution of Annexure P-2, dated 21.05.2021, shall remained stayed. However, this protection is subject to the writ petitioner making the afore representation, within a period of one week from today. Liberty is reserved to the writ petitioner to file appropriate court, if he still remains aggrieved.”

And whereas, upon passing of above directions, petitioner submitted a representation and requested to cancel his transfer orders or in the alternative he may be adjusted at GSSS Bhutti/Kharahal/Haripur against vacancy in Distt.Kullu due to his family circumstances. So as per directions of Hon'ble Court, the petitioner was directed to appear in person in Directorate of Higher Education, HP, Shimla-1 and was heard in person on 18.06.2021. During the course of hearing, he again requested to cancel his transfer orders.

And whereas, after going through the record i.e fact finding report submitted by Deputy Director of Higher Education Kullu it is found that he has violated Rule 3(1)(VIII) and Rule 9 of the CCS (Conduct Rules) 1984 and accordingly he was transferred from his present place of posting.

Now therefore, it is a *prima facie* case of violation of CCS (Conduct Rules), hence there is no need to interfere the earlier orders dated 21.05.2021 as he has already completed his normal tenure at GSSS Manali (KLU) and as per R & P Rules he can be transferred anywhere in State. Accordingly, he is directed to join at GSSS Milah (SMR) immediately in public interest.

With these observations, representation stands disposed of.


