Memo,

It has brought to the notice of undersigned by the Deputy Director of Higher/Elementary Education Kangra through the Deputy Commissioner, Kangra at Dharamshala that all Private Schools of District Kangra (specially affiliated to CBSE & ICSE Board) are not cooperating and not following the instructions issued by the office of DDHE/DDEE, Kangra at Dharamshala, like distribution of medicines (Iron Folic Acid & Albendazole etc.).

In this connection, it is informed that the implementation of National Health Programs through schools like distribution of de-worming Albendazole tablets and IFA Tablets to school going children has been made mandatory by Central Government, but you are showing reluctance in implementing these programs. Therefore you are hereby directed to collect Albendazole Tablets from their concerned Education Blocks (copy enclosed) and submit monthly WIFS report to their concerned blocks before 10 day of every month.

These instructions may be complied with strictly and in case of any laxity concerned School/Head of Institution shall be held responsible and disciplinary action as warranted under rules shall be initiated against the School.

This should be treated as urgent.
