NOTIFICATION

In supersession of this department Notification of even numbers dated 24<sup>th</sup> May, 1999 and 27<sup>th</sup> July, 2000, the Governor, Himachal Pradesh pleased to order the delegation of powers to declare the articles of Store or Stock surplus or unserviceable and to sanction sale of articles of store or stock declared surplus or unserviceable shall be as under:-

NOTE:- (i) To declare articles of Store or Stock surplus or unserviceable and for disposal/sale under above provisions, the procedure laid down in the MPFR, 2009 and other relevant rules shall be followed.

(ii) The concerned department will ensure that the vehicles/store articles so condemned are auctioned positively within three months of their being declared surplus or unserviceable and money deposited in the treasury.
