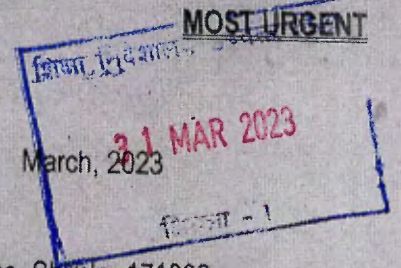

Subject: **Aadhaar Authentication beneficiaries reporting under the DBT Schemes on DBT Portal.**

Sir/Madam,

It is to bring to your kind notice that Direct Benefit Transfer (DBT) is a major reform initiative of Government of India to re-engineer delivery processes by leveraging ICT based technological environment. Aadhaar is the key infrastructure component in this eco system. DBT Mission Cabinet Secretariat has laid emphasizes upon the fact vide its O.M. No. D-26011/03/2017-DBT(Cab.) dated 14.02.2023 that the Aadhaar authentication is to be conducted in all DBT schemes, in accordance with the guidelines issued by the Unique Identification Authority of India (UIDAI). It is to be ensured that while reporting monthly progress for DBT Schemes on DBT Portal, number of Aadhaar authenticated beneficiaries may be reported.

The Ministry of Education, Department of School Education & Literacy Shastri Bhavan, New Delhi has also given direction to ensure strict compliance of the instructions issued by DBT Mission Cabinet Secretariat vide DO. No. F.10-2/2023-IS.7 dated 16th February, 2023 regarding reporting of Aadhaar authentication in DBT Schemes.

In view of the above, all concern are requested to implement the above direction on top priority given by the DBT Mission Cabinet Secretariat, New Dehli and Unique Identification Authority of India (UIDAI) regarding reporting of Aadhaar authenticated beneficiaries number under DBT Schemes on DBT Portal.

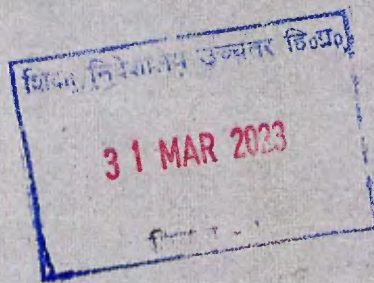


