Regarding AISHE 2023-24 Survey tentatively launched (aishe.gov.in)

Sir,

It is in reference to D.O. NO. 19-1/2024-Stat email dated 11.11.2024 received from Smt. Navanita Gogoi Deputy Director General Govt. of India Ministry of Education Department of Higher Education Shastri Bhavan New Delhi addressed to the State Nodal Officer Directorate of Higher Education H.P. on the subjected cited above.

In this context it is intimated that AISHE 2023-24 has been launched on 18th November 2024 and is to be completed by January 31, 2025 in a time bound manner. There are few factors most important for any survey, viz, quality, coverage and timeliness of the data. As far as AISHE 2022-23 is concerned, though over 90% of the institutions submitted their data on time, several inconsistencies were identified in the data captured, which eventually extended the survey period by an additional three months, as we needed to address or resolve these inconsistencies through follow-ups and reviews, to the extent possible. It is pertinent to mention here that, considering the wide use of AISHE data, any inconsistencies or errors in the data collected through AISHE can compromise the survey's integrity and policy decisions that rely on it, so all those inconsistencies need to be addressed before releasing the survey results.

In this regard you are requested to kindly direct all the Higher Education (Govt., Private & Standalone) under your control/ affiliated with you to upload the data on AISHE Portal (aishe.gov.in) 2023-24 before 31st January 2025 and also direct the newly opened institutions for registration on AISHE Portal immediately.
