<u>ORDER</u>

Whereas, the petitioner namely Smt. Aruna Gautam, Lecturer (SN) Hindi who is working at GSSS Sarsoo(Smr) w.e.f. 20.04.2021 has filed CWP No. 8500/2022 titled as Aruna Gautam Vs State of HP before the Hon'ble High Court seeking there in relief regarding her transfer. This petition was listed on dated 07.12.2022 when the Hon'ble Court has given following directions:-

"In the Circumstances, without expressing any opinion on the merit of the case, we dispose of the petition by directing that if the petitioner makes a representation within one week from today, the same shall be decided by respondent No. 2 expeditiously and in any event within three weeks from the date of receipt of representation. All pending applications to stand disposed of accordingly."

And whereas, upon passing of above direction the representation from the petitioner has been received on 12.12.2022, vide which she has requested that she is on verge of retirement and her present station is far from her native place and not suitable for her health hence, she may be transferred to GSSS Shoghi(Sml) against vacancy being caused due to retirement of present incumbent on 31.01.2023.

And whereas, as per the direction passed by the Hon'ble Court as above, the representation/request of the petitioner has been considered and rejected as there is no vacancy of Lect(Hindi) in GSSS Shoghi(Sml) as on today hence, not administratively feasible. More over during her entire services she has served mostly in and around Kandaghat (SIn) which is her native place and at her present station i.e. GSSS Sarsoo (Smr) she has not completed her normal stay as she is working there w.e.f. 20.04.2021.

Now therefore, after taking into account the above discussed detailed facts and circumstances, the request of the petitioner can not be acceded to. Hence, she will continue at GSSS Sarsoo Distt. Sirmour till completion of her normal stay.

May inform the parties accordingly.
