



It will be ensured that in the event of teacher being transferred, the transferred teacher shall join duty only when the person occupying the post is relieved first, only thereafter, the joining of incumbent shall be accepted. The concerned Principals are also directed to ensure that consent be obtained before relieving and joining of both officials. It may also be ensured that the relieving/joining of incumbent may be entered in PMIS immediately. **It may also be ensured that in case of transfer in r/o NCC ANO these orders may not be implemented and intimate this Directorate immediately**
