OFFICE ORDER

Whereas, Sh. Bhag Singh, DPE who is under orders of transfer from GSSS Sanio Deedag (Sirmour) to GSSS Makroli (Kangra) against vacancy in public interest vide this office order dated 11.09.2024 has filed CWP No. 10479/2024 before the Hon'ble High Court against this transfer orders.

The case was listed before the Hon'ble High Court on 19.09.2024 when the case was disposed of with the following directions:-

"Having heard Learned counsel for the petitioner and taking into consideration the fact that the petitioner has already completed his normal tenure at the present place of posting. Though, the Court is not interfering with the transfer order, but in the light of the averments made in the writ petition that the wife of the petitioner is suffering from paralysis, the petitioner is allowed to make a representation for his adjustment at some other station and, in case any such representation is filed within a period of one week from today, then let the same be considered sympathetically within a period of two petitioner shall be allowed to serve at Sanio Deedag i.e. his present place of posting, as none has been posted in his place, pending miscellaneous applications, if any also stand disposed of."

And whereas, upon passing of above directions, petitioner has submitted his representation on dated 25.09.2024 vide which he has requested to adjust him at the choice of stations i.e. GSSS Bharoli /Ludhiana/ Jadol Taproli (Sirmour) against vacant post.

Now therefore, after taking into account the above discussed detail fact and circumstances, a request of the petitioner has been considered and rejected and transfer orders of petitioner i.e. Sh. Bhag Singh, DPE from GSSS Sanio Deedag (Sirmour) to GSSS Makroli (Kangra) issued vide this office order dated 11.09.2024 is being cancelled in the interest of students.

With these observations, representation stands disposed of.
