ORDER

Whereas, Sh. Bharat Singh, Lecturer (School-New) (Economics) was filed CWP No. 2776/2023 before the Hon'ble High Court regarding his transfer from GSSS Bharog Baneri, Distt. Sirmour to GSSS Nihalgarh, Distt. Sirmour against vacancy being caused due to retirement of Smt. Veena Kothiyal on 30.06.2023. The case was listed before the Hon'ble Court on 15.05.2023 when the case was disposed of with the following directions:-

"Petitioner is permitted to make representation to responder No. 2 alongwith supported documents on or before 22.05.2023. In case such representation is preferred, same shall be decided by respondent No. 2 on or before 05.06.2023, by passing speaking and reasoned order, after giving option of personal hearing to the petitioner, if desired so. Order shall be communicated to the petitioner immediately thereafter"


And whereas, upon passing of above directions, petitioner, Sh. Bharat Singh, Lecturer (School-New) (Economics) submitted a representation and requested that due to his medical problems he is not able to serve at GSSS Bharog Baneri (SMR). He further requested to adjust him at GSSS Nihalgarh (SMR) against vacancy being caused due to retirement of Smt. Veena Kothiyal, Lecturer (English) on 30.06.2023.

Now therefore, after taking into account the above facts and circumstances of the case, representation of petitioner is considered sympathically and the petitioner i.e. Sh. Bharat Singh, Lecturer (School-New) (Economics) is hereby transferred from GSSS Bharog-Baneri (SMR) to GSSS Nihalgarh (SMR) against vacancy being caused due to retirement of Smt. Veena Kothiyal, Lecturer (English) on 30.06.2023 in condonation of short stay & without TTA/JT. **These orders shall come into force on or after 01.07.2023.**

With these observations, representation stands disposed of.
