NOTIFICATION

In order to enhance the Ease of Doing Business in the State of Himachal Pradesh and in consonance with the Business Reforms Action Plan circulated by Department for Promotion of Industry and Internal Trade, Ministry of Commerce & Industry, Government of India, the Governor of Himachal Pradesh, is pleased to notify the following:-

- (i) The departments concerned will encourage strong engagement between industry experts, the community and key stakeholders to ensure that the person concerned is informed of the new initiatives, strategies, guidelines that the Government is planning to roll out.
- (ii) Feedback and consultations of industry and community will be taken into account before finalizing or issuing business/investment/industrialization related legislations, policies, guidelines and strategic initiatives. State Government shall solicit the feedback through various modes, one of them is feedback form developed within the 'Investor Services' on Industries Department's website (<https://emerginghimachal.hp.gov.in/feedback>). The industry experts/ investors giving their feedback will also be able to view the comments on the website with the updates, if any.
- (iii) Each draft business regulation shall be published online for a period not less than 30 days to invite public comments/ feedback on the same prior to enactment and also shall publish online the comments/feedback received

on the draft business regulation and how they have been addressed in the final regulation.

- (iv) The legal basis, necessity and business-friendly aspect of each draft business regulation along with the draft shall be published online.
- (v) The Commissioner/Director of Industries, Himachal Pradesh will be the Nodal Authority for above mentioned purposes.
