Subject:- **Regarding Points Noted by the Cabinet on May 8th, 2020.**

In pursuance to the GoHP letter No.EDN-B-F(10)8/2019 dated 15-05-2020, received from the Principal Secretary (Education) to the Government of Himachal Pradesh, on the above mentioned subject. You are directed to circulate necessary instructions to all the Heads of Government Senior Secondary/ High Schools in your respective District, to access the fiscal space available in their respective school accounting for all the funds lying unutilized including in various bank accounts or in the form of FDs and other instruments. This exercise should also be done for accrued interest amounts. It is extremely important to utilize these funds during the current financial year to increase public expenditure and to give pace to the development in the State. It may be ensured to achieve at least 75% utilization of funds (except Build Fund) by December, 2020.

Besides this, if there is any requirement for the simplification of various procedures and rules pertaining to financial aspects incorporated in H.P. Secondary Education Code-2012, Chapter-4, Sub-chapter 4.6.1 to 4.6.14, in that case matter may be brought to the notice of undersigned by the concerned Deputy Director of Higher Education, immediately, so that further action could be taken in the matter accordingly.

This may be given personal attention and top priority please.

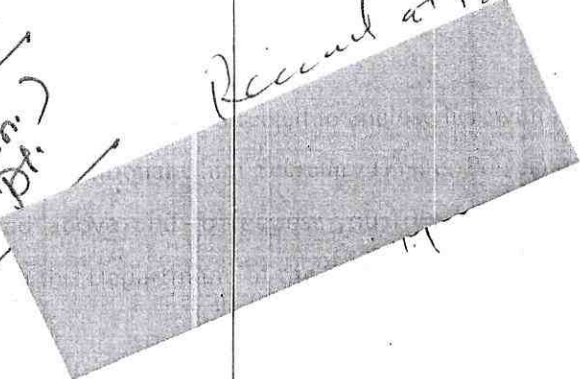

A presentation was made before the Cabinet on Economic Revival on behalf of Cabinet Sub Committee by the undersigned on May 8th, 2020. On certain points, the Cabinet decisions will be conveyed through the GAD, however there were certain points in the presentation which were noted by the Cabinet. These points are follows:

- i) The Departments should assess the fiscal space available with them, their field Offices, Boards, Corporations, Societies and Committees etc. accounting for all the funds lying unutilized including in various bank accounts or in the form of FDs and other instruments. This exercise should also be done for accrued interest amounts. It is extremely important to utilize these funds during current financial year to, increase public expenditure and to give pace to the development in the State. The position of funds should be reported to the Finance Department by 17th May. Please make up for the loss of first quarter of this financial year in the second and third quarter. Please try to achieve at least 75% utilization of funds by December, 2020.
- ii) The Department should review various procedures and rules pertaining to financial aspects and if there is a requirement of simplification of procedures, please write to the Principal Secretary (Fin.). These will be examined by FD on priority.
