NOTIFICATION

In exercise of powers conferred by proviso to article 309 of the Constitution of India, the Governor of Himachal Pradesh is pleased to make the following rules further to amend the Central Civil Services (Leave) Rules, 1972, in their application to the State of Himachal Pradesh, namely:-

- Short title and commencement 1.
- These rules may be called the Central Civil Services (Leave) Himachai Pradesh Amendment Rules, 2024.
- (2) They shall come into force from the date of their publication in Rajpatra (e-Gazette), Himachal Pradesh.

Insertion of rule 43-C.

 In the Central Civil Services (Leave) Rules, 1972, in their application to State of Himachal Pradesh, after rule 43-B the following shall be inserted, namely:-

"43-C. Child Care Leave

(1) Subject to the provisions of this rule, a female Government servant may be granted child care leave by an authority competent to grant leave for a maximum period of seven hundred and thirty days during her entire service for taking care of her child with a minimum disability of forty per cent as specified in the Government of India Ministry of Social Justice and Empowerment's Notification No. 16-18/97-N 1.1, dated the 1st June, 2001 up to two surviving children.

(2) Grant of child care leave to a female Government servant under sub-rule (1) shall be subject to the following conditions, namely:-

(i) it shall not be granted for more than three spells in a calendar year;

- (ii) in case of a single female Government servant, the grant of leave in three spells in a calendar year shall be extended to six spells in a calendar year;
- (iii) it shall not ordinarily be granted during the probation period except in case of certain extreme situations where the leave sanctioning authority is satisfied about the need of child care leave to the probationer, provided that the period for which such leave is sanctioned is minimal; and
- (iv) Child care leave may not be granted for a period less than five days at a time.
- (3) During the period of child care leave, a female Government servant shall be paid one hundred per cent of the salary for the first three hundred and sixty-five days, and at eighty per cent of the salary for the next three hundred and sixty-five days.
- (4) Child care leave may be combined with leave of any other kind.
- (5) Child care leave shall not be debited against the leave account.".
