

Sir/Madam,

In recognition of valuable contribution of our teachers during the pandemic and to take new Education Policy (NEP)2020 a step forward, the department of School Education and literacy, Ministry of Education would be celebrating Shikshak Parv, 2021. The theme for this year's Shikshak Parv has been decided as Quality and Sustainable Schools: Learnings from the Schools in India.

1. During the Shikshak Parv, the President of India will be giving awards to the teachers from different parts of the country on 5 September, 2021.
2. On 7<sup>th</sup> September, 2021 at 11 AM, the Hon'ble PM will be addressing the Inaugural Session of the Education Conclave wherein a large number of Teachers, Parents and students would be participating.
3. From 7<sup>th</sup> onwards till 17<sup>th</sup> of September, a series of webinars, discussions, presentations etc. have been planned in which the educational practitioners from various schools of the country have been invited to share their experience, learning and the roadmap ahead.

You are requested to take the following initiatives to make Shikshak Parv a grand success:

1. Kindly advise Teachers, Principals, CRCS, BRCS, Regional Offices and other field formatives etc. under your jurisdiction to participate and benefit from the inaugural address/conclave and webinar series.
2. The department has decided to call for suggestions from school teachers and principals and other stakeholders from all over the country on their views on areas, as curriculum, pedagogy inclusion, assessment etc. For this purpose, a questionnaire with multiple choice questions will be uploaded on MyGov on 5 September under the link: <https://innovateindia.mygov.in/stakeholder-engagement-for-NEP2020/>. The teachers and the principals may be advised to go to the link and give their views.


