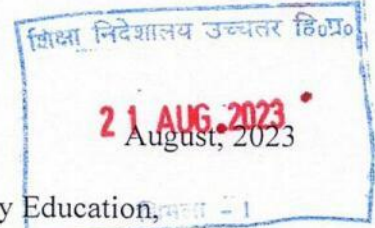

Subject: - Regarding Collection of data for Post Disaster Need Assessment (PDNA) for Monsoon Season-2023.

Sir,

Please find enclosed herewith the letter received from Director-cum-Spl. Secy. (Rev-DM), dated 18.08.2023 on the subject cited above and to inform you that Himachal Pradesh State Disaster Management Authority (HPSDMA) is conducting Post Disaster Needs Assessment on account of the damage occurred during the period from 09<sup>th</sup> - 11<sup>th</sup> July, 2023. Initially the PDNA exercise was carried out by the worst affected six districts viz. Chamba, Kullu, Kinnaur, Mandi, Shimla and Solan under the guidance of District Administration.

Now, PDNA exercise on the same analogy adopted for the earlier districts is to be carried out in your respective districts also for damages and losses occurred during the first spell from 9<sup>th</sup> to 11<sup>th</sup> July, 2023 and the second spell from 11<sup>th</sup> - 15<sup>th</sup> August, 2023. You are, therefore, directed to go through the contents of the letter and being a designated district level officer, coordinate with other Members of Sectoral Team so that whole exercise could be carried out before 26<sup>th</sup> August, 2023.

**Subject: Regarding Collection of data for Post Disaster Need Assessment (PDNA) for Monsoon Season-2023.**

Sir,

I am directed to refer to subject cited above and to say that the Himachal Pradesh State Disaster Management Authority (HPSDMA) is conducting Post-Disaster Needs Assessment (PDNA) on account of the damages occurred during the current monsoon season. Initially the PDNA exercise was carried out for the worst affected districts of the State viz. Chamba, Kullu, Kinnaur, Mandi, Shimla, and Solan in collaboration with National Disaster Management Authority (NDMA), MHA, Govt. of India. The purpose of this assessment is to seek financial assistance under the recovery and reconstruction window of the National Disaster Response Fund (NDRF).

In this regard a virtual meeting was held on 17<sup>th</sup> August 2023 under the Chairmanship of Sh. Krishna S.Vatsa, Hon'ble Member NDMA, Ministry of Home Affairs, Govt. of India to discuss the current situation of the state and review the progress of the ongoing PDNA Exercise. The following decisions were taken in the meeting:

1. NDMA would extend its support for including the damages occurred during the recent spell of destruction.
2. To Collect and update the Sector wise field data for the six districts, where the exercise is being carried out presently to include the damage and losses occurred during the period from 11<sup>th</sup> -15<sup>th</sup> August, 2023.
3. Collection of Sector wise field data for carrying PDNA exercise on the same analogy for the remaining six districts of the State i.e. Kangra, Bilaspur, Una, Sirmour, Hamirpur and Lahaul & Spiti.
4. Both the exercises are to be completed by 26<sup>th</sup> of August, 2023.
5. Field Visit of the Central Team (may be a smaller group) will be conducted sometimes after 26<sup>th</sup> August, 2023 for validation.



In view of the above decisions taken, it is proposed that the remaining six districts (Bilaspur, Hamirpur, Kangra, Lahaul & Spiti, Sirmour and Una) be taken up for carrying of the PDNA exercise on the same analogy adopted for the earlier districts. In order to complete the exercise, the district level teams shall be constituted comprising of ADC/ADMs (District Administration), Superintending Engineers (PWD, JSV, Housing and Power), Chief Medical Officers (Health), Deputy Directors (Higher Education) and Dy. Directors (Agriculture/Horticulture/Animal Husbandry) & DTDO (Tourism). The sectoral teams would be responsible for collecting the data for the damages and losses occurred during the first spell from 9-11 July, 2023 and the second spell from 11-15 August, 2023 from their respective districts departments, so that a PDNA document could be evolved. The data thus generated would be filled up in the Google Forms/Sheets which shall be circulated to all the sectoral teams, led by the CEOs of the DDMA's of the respective districts. Kindly ensure that the whole exercise for data generation and filling up the data in the Google Forms/Sheets is completed by the 26<sup>th</sup> August, 2023.

In view of the above, you are kindly requested to issue necessary instructions to the concerned departments for the deputation of the designated district level officers as the Members of Sectoral Teams. The details of the designated officers (including their WhatsApp numbers and Email IDs) for all the sectoral teams may kindly be shared with the undersigned for directly interacting with them.
