



All the Principals may ensure consent of all the officials before relieving/joining. It may also be ensured that the relieving/Joining of incumbent may be entered in PMIS immediately. It may also be ensured that in case of transfer in r/o NCC ANO these orders may not be implemented and intimate this Directorate immediately.
