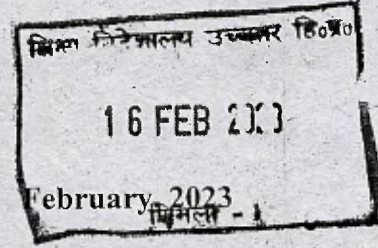




**OFFICE ORDER**


