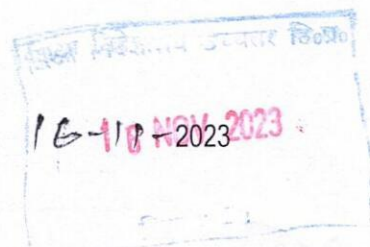




OFFICE ORDER


