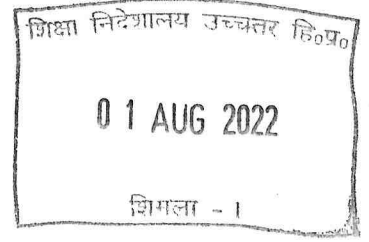

If the controlling officer does not comply with this procedure, the salary of the surplus incumbent will be drawn from the salary of the controlling officer. It may also be ensured that the relieving/joining of the concerned officials may be entered in PMIS immediately. In case of transfer in r/o NCC ANO, these orders may not be implemented and intimate this Directorate immediately.**
