Regarding uploading of the certificate in digital format in the Digilocker, linked with the Aadhaar Number of the student for scholarship.

Sir,

It is to bring to your kind notice that Ministry of Social Justice and Empowerment, Government of India is implemented the Centrally Sponsored Post Matric Scholarship Schemes for SC students. The revised scheme envisages a robust IT Framework that, seamlessly and on real-time, verifies the eligibility upon entry of the Aadhaar Number of the student in the Registration page by auto-check of the online database of the (a) Income Certificate, (b) Caste Certificate, (c) Domicile Certificate and (d) Educational certificate/mark sheet of the candidate. This would require that the above the digital format of the certificates issued by the certificate issuing authorities in the State is uploaded on the Digilocker, on a real-time basis, linked with the Aadhaar number of the student. This will eliminate the vexatious process of manual verification of the scanned /pdf certificates by local authorities which invariably delays the process of sanction of the Scholarships.

All the District Collectorate Offices of Himachal Pradesh also requested to place hoardings of the State, Central and Minority Scholarship Schemes and promote the awareness for the needy and poor students as well as Institution Registration on National Scholarship Portal (NSP).
