Notification

In order to prevent the spread of drug addiction/drug abuse in the villages of Himachal Pradesh the Governor, Himachal Pradesh is pleased to constitute "Nasha Nivaran Committees" at Panchayat level. The composition of the Committees shall be as under:

1. Principal/Headmaster of Local Government School	Chairman
2. Secretary/Panchayat Sahayak of concerned, Gram Panchayat	Member
3. Village Revenue Officer (Patwari).	Member
4. Local ASHA Worker	Member
5. Member of Mahila Mandal/Youth Representative.	Member
6. Prominent Social Worker/Senior Citizen/Volunteer	Member
(to be nominated by concerned BDO).	
7. Police Head Constable/Constable of concerned area.	
(Specifically designated by concerned SHO)	Member Secretary

All Deputy Commissioners through concened Block Development Officers are directed to ensure the timely constitution of these Committees at the Panchayat level and provide necessary administrative support for their effective functioning.

The Committees shall convene meetings at monthly basis to:

- Assess and review the local situation regarding drug abuse:
- Monitor and gather intelligence on Heroin/Chitta-related activities, including identification of peddlers, consumers, addicts, or any suspicious activities, and facilitate timely sharing of this information with local police station or other law enforcement agencies in the state;
- and awareness programmes in schools, sensitization Conduct communities, and public spaces;

- Coordinate with law enforcement agencies and local administration to address emerging concerns, identify at-risk youth and families affected by drug abuse,
- Recommend Action Plans and community-based interventions to prevent the spread of substance abuse.

## Reporting Mechanism:-

- The Committees shall report and coordinate their action through concerned Deputy Commissioner in the District.
- Concerned Deputy Commissioner in coordination with the Superintendent
  of Police shall quarterly review the action/recommendation of their
  "Nasha Nivaran Committee;" and take follow up action as required in
  order to curb menace of drug abuse and drug addiction.
- Period quarterly report shall be sent to Additional Chief Secretary (Home)
  to the Govt. of Himachal Pradesh and the Director General of Police,
  Himachal Pradesh for their perusal and follow up actions.
- Additional Chief Secretary (Home) to the Govt. of Himachal Pradesh and the Director General of Police, Himachal Pradesh shall supervise and take necessary action required for the effectiveness of these Nasha Nivaran Committees.


