The Principal, GSSS Bagain (SML)/Dharampur (SLN)/Bhojnagar (SLN), HP with the direction that the incumbent working under your establishment be relieved immediately failing which disciplinary action will be initiated against the defaulter under the rules and also to ensure that there is no court case before relieving/joining the above said officials. It will be ensured that in the event of a teacher being transferred, the transferred teacher shall join duty only when the person occupying the post is relieved first, only thereafter, the joining of the incumbent shall be accepted.
