Subject:- Regarding Students "Learning Enhancement Guidelines".

In pursuance to Government of Himachal Pradesh letter No.EDN-B-Ka-(4)-1/2018-L dated 02-09-2020, on the above mentioned subject. As you are aware that during the COVID-19 pandemic, State Government is making efforts for providing education to the Students at their homes through alternative means of delivery such as, online classes under the programme "Har Ghar Pathshala", classes on Doordarshan Shimla under ~~under~~ "Himachal Doordarshan Gyanshala Programme" and digital content through various media which have been placed on the Departmental site, activity based learning through the Alternate Academic Calendar released by the NCERT and work sheets etc. Notes and study material are also being provided to the Students of those areas where network connectivity is not working properly or the students who do not have the facility to access smart phones.

The alternative modes have, however, certain limitations. Equitable quality learning for all students is a challenge due to various factors such as unequal distribution of time of teachers, students having differential access to technological devices and lack of support for learning at homes in several areas. As a result, closure of schools is likely to lead to loss of learning and deficiencies in the achievement of students' learning outcomes.

With a view to addressing the issues related to gaps and / or loss of learning among students, during and after the lockdown, the NCERT has prepared 'Students' Learning Enhancement Guidelines' with a focus on learning outcome. These guidelines suggest models for the following three types of scenarios:-

1. Learning Enhancement during COVID-19 for Students without digital devices.
2. Learning Enhancement during COVID-19 for Students with limited accessibility to digital devices.
