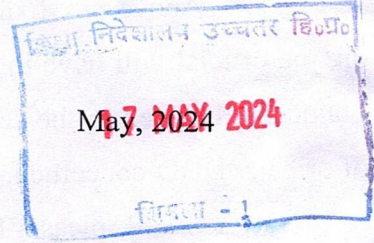


OFFICE ORDER

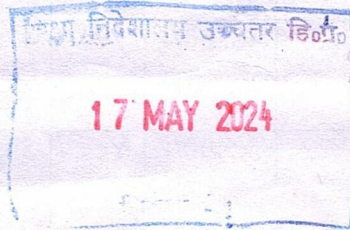

