



As per para 2.2 (x) of Section-I (Part-II) of the Flag Code of India, the National Flag ide of paper may be waved by public on occasions of important national, cultural and orts events. You are requested to ensure that on the occasions of important national, itural and sports events, Flags made of paper only are used by the public and such paper ags are not discarded or thrown on the ground after the event. Such Flags are to be sposed of, in private, consistent with the dignity of the Flag.

You are requested to undertake mass awareness programme in this regard and also to e it wide publicity through advertisements in the electronic and print media.

EVENTION OF INSULTS TO NATIONAL HONOUR ACT, 1971 No. 69 of 1971

(23rd December, 1971)

aded by the Prevention of Insults to National Honour (Amendment) Act, 2005) No. 51 of 2005 (20th December, 2005)

An Act to Prevent Insults to National Honour

Be it enacted by Parliament in the Twenty- second year of the Republic of India follows: -

SHORT TITLE AND EXTENT

- This Act may be called the Prevention of Insults to National Honour Act, (1)1971
- (2)It extends to the whole of India.

INSULT TO INDIAN NATIONAL FLAG AND CONSTITUTION OF INDIA

Whoever in any public place or in any other place within public view burns, mutilates, defaces, defiles, disfigures, destroys, tramples upon or *otherwise. shows disrespect to or brings into contempt (whether by words, either spoken or written, or by acts) the Indian National Flag or the Constitution of India or any part thereof, shall be punished with imprisonment for a term which may extend to three years, or with fine, or with both.

Explanation 1 - Comments expressing disapprobation or criticism of the Constitution or of the Indian National Flag or of any measures of the Government with a view to obtain an amendment of the Constitution of India or an alteration of the Indian National Flag by lawful means do not constitute an offence under this section.

Condition 2 - The expression, "Indian National Flag" includes any picture, painting, chawing or photograph, or other visible representation of the Indian National Flag, or of any part or parts thereof, made of any substance or represented on any substance,

Explanation 3 - The expression "public place" means any place intended for use by, or accessible to, the public and includes any public conveyance.

13. planation 4 - The disrespect to the Indian National flag means and includes—

- a gross affront or indignity offered to the Indian National Flag; or (a)
- dipping the Indian National Flag in salute to any person or thing; or (b)
- flying the Indian National Flag at half-mast except on occasions on which (c) the Flag is flown at half-mast on public buildings in accordance with the instructions issued by the Government; or

- using the Indian National Flag as a drapery in any form whatsoever except in state funerals or armed forces or other para-military forces funerals; or
- #using the Indian National Flag:
 - as a portion of costume, uniform or accessory of any description (i) which is worn below the waist of any person; or (ii)
 - by embroidering or printing it on cushions, handkerchiefs, napkins, undergarments or any dress material; or
- putting any kind of inscription upon the Indian National Flag; or (f)
- using the Indian National Flag as a receptacle for receiving, delivering or (g) carrying anything except flower petals before the Indian National Flag is unfurled as part of celebrations on special occasions including the Republic Day or the Independence Day; or
- using the Indian National Flagas covering for a statue or a monument or a (h) speaker's desk or a speaker's platform; or
- allowing the Indian National Flag to touch the ground or the floor or trail
- draping the Indian National Flag over the hood, top, and sides or back or (j) on a vehicle, train, boat or an aircraft or any other similar object; or
- using the Indian National Flag as a covering for a building; or (k)
- intentionally displaying the Indian National Flag with the "saffron" down. (1)

PREVENTION OF SINGING OF NATIONAL ANTHEM

Whoever intentionally prevents the singing of the Indian National Anthem or causes disturbances to any assembly engaged in such singing shall be punished with imprisonment for a term, which may extend to three years, or with fine, or with both. #3A

MINIMUM PENALTY ON SECOND OR SUBSEQUENT OFFENCE

Whoever having already been convicted of an offence under section 2 or section 3 is again convicted of any such offence shall be punishable for the second and for every subsequent offence, with imprisonment for a term, which shall not be less than one year.
