Sir,

I am directed to refer to the subject cited above and to say that the matter regarding payment of garbage collection fees/charges payable to the Shimla Environment, Heritage Conservation & Beautification Society (SEHB) of Municipal Corporation Shimla on account of collection of garbage from the door steps of the offices of Government Departments/entities/ Hospitals etc. was taken up with the Finance Deptt., Govt. of HP. The Finance Department has approved the proposal for making payment on account of collection of garbage fee/charges from the appropriate SOE vide Dy. No. 55118080 Fin-IF(C) 10-212019 dated 01.09.2020, the relevant extract of which is reproduced as under:-

"Examined. The AD(UD) is advised that the FD has "no objection" if Government department/entities /Hospitals etc. pay Garbage collection fee/charges from their budget heads from appropriate SOE such as "Office Expenses" or "Other Chargers" or any other appropriate SOE. In case, there is budget short fall for this expenditure, the departments may seek appropriate additionality or re-appropriation for the Garbage collection charges"

It is, therefore, requested to issues necessary directions to all HoDs under your control to pay Garbage collection fee/charges to the respective municipality from their budget
