Sir,

As you are aware that the elections to Panchayati Raj Institutions and Urban Local Bodies are scheduled to be held by the end of this year probably in the month of December, 2020/ January, 2021. Article 243K(3) Constitution of India read with Section 160(3) of HP Panchayati Raj Act, 1994, provides that the Governor shall, when so requested by the State Election Commission, make available such staff as may be necessary for the discharge of functions conferred on him under this Act. Further, Section 160A of the Act ibid provides that any premises needed or are likely to be needed for the conduct of elections will be provided by the State Government.

The Commission would require school premises, furniture and staff for the conduct of these elections. Therefore, I am directed to request you to plan the schedule of exams of winter closing school in such a manner that these elections may be conducted smoothly.
