**ORDER**

No. EDUB-E05/9/2023

Dated: Shimla-2, the 07-12-2023.

Whereas Sh. Hardev Kaundal, Principal, approached the Hon'ble High Court vide CWP No. 8202 of 2023 seeking his transfer on ground that he has completed normal tenure at GSSS Kungal Balti, Distt. Shimla and further on the grounds of adverse family circumstances. The Hon'ble High Court on dated 02.11.2023 decided the matter and the operational part of the judgement is as under:-


"In this background, this Court permits the petitioner to make a fresh representation in conformity with Clause 16.1 of the Policy-Guidelines to the Respondent no.1- Principal Secretary(Education), within a week from today, who shall examine the same and to pass appropriate orders, strictly in conformity with the mandate of Clause 12 and Clause 16 of the Transfer Policy/Guidelines within two weeks, thereafter, and that too after affording a personal hearing of the petitioner. Petition stands disposed of so also the pending miscellaneous application(s), if any."

2. Whereas, as per the directions of Hon'ble High Court the petitioner was afforded an opportunity of being heard in person on 28.11.2023. During the course of hearing, the petitioner submitted that he belongs to District Mandi and he has completed normal tenure of three years at GSSS Kungal Balti, Distt. Shimla and further, submitted that his mother who is 85 years old lady is suffering with many old aged ailments and needs attendant at times. He had further submitted that there is no one to look after his mother as his wife is also working as TGT (Arts) and posted in Shimla District and his children are studying outside.
- 3 Whereas it is a fact that Sh. Hardev Kaundal, Principal has completed normal tenure at present place of posting which is a rural/remote area, but it does not fall under

Difficult/Tribal/Hard Areas. During the hearing Sh. Hardev Kaundal, Principal was asked to submit a few preferences with vacant stations as per policy.

- 4 Sh. Hardev Kaundal submitted a list of stations where he would like to get posted.
- 5 Now therefore, the undersigned after careful consideration of the facts and circumstances of the case decides to post him at GSSS Rohanda, Distt. Mandi against vacancy. It is important to note that GSSS Rohanda was one of his preferred stations. Hence, the representation is disposed off.


