Sir,

I may have the pleasure of informing you that the project proposal entitled "Setting up of Herbal Garden in schools under Education Department of Himachal Pradesh" has been approved by the National Medicinal Plants Board (NMPB), Ministry of AYUSH, Government of India. While approving the proposal the NMPB has submitted following observations, which are required to be attended before the release of funds.

- 1. The School Principal will give undertaking about post project maintenance & also certify that Herbal Gardens are made in areas which will not be required for construction. Initially the project will be implemented in TT schools so undertaking from 75 schools is required
- 2. At least there should be one school per assembly constituency in the state.
- 3. An undertaking for maintenance of herbal gardens for 10 years from the competent authority i.e Director Higher Education, H.P. and also mention that proposed land not to be diverted for any other purposes in future.

4. The school must have boundary wall and irrigation facilities.

It is, therefore, requested to attend the above said observations and submit requisite documents as stated above within two days for the release of funds from the GoI for the implementation of the project.
