Regarding grant of Annual Increment benefit.

On the subject cited above it informed that matter was taken up with Govt. to grant annual increment to the AP whose services were taken over from privately managed colleges/GIA colleges by the Govt. with the condition that they will qualify NET/SET examination until no annual increment will be granted.

In this regard, the Govt. has sought following information:-

How many incumbents are there whose services were taken over but they
were not fulfil the eligibility criteria at the time of taken over their services.

- 2. How many incumbents are there whose services were taken over but annual increment is not being awarded to them with the reason that they have not qualify NET/SET examination as fixed by the Govt. at the time of taken over their services. Detail be given with name, Designation & place of positing at present.
- 3. How many cases are in you college in which Government had decided not to take over services of those incumbents who have not fulfilled the minimum eligibility criteria neither at the time of their initial appointment nor at the time of taking over of their services? Number of candidates be supplied in which it has been decided to take over the services of the candidates to the lower post (Lect. School PGT) for which they were eligible alongwith name & particulars
- 4. If the Government considers the proposal under reference as to whether the incumbents, whose services have been taken over as PGT School cadre/Lower post will not demand for similar benefits? Legal implication in this regard be provided.

within two days through e-mail so that Govt. could be apprised.
