Instructions regarding Implementation of Post-Matric Scholarship Scheme and Pre-Matric Scholarship Scheme for SC Students & Others for AY 2023-24.

Sir.

In compliance to D.O. No.:K-11017/1/2022-SCD-V dated 25-10-2023, received from Sh. Saurabh Garg, IAS, Secretary, Ministry of Social Justice and Empowerment, Department of Social Justice and Empowerment, Gol, New Delhi and refer to the letter No.SJE-B-F010/1/2023-S J and E-II-Himachal Pradesh Secretariat dated 11-10-2023, on the above cited subject.

In this regard, it is brought to your kind notice that Government of India has made mandatory that the eligibility certificates of the students i.e. Bonafide/ Domicile Certificate, Income Certificate, Caste Certificate, Educational Certificates/ Diploma's/ Degree etc., must be integrated with Digilocker, so that digital / auto-verification of these documents/ certificates could be done for the release of scholarship under these schemes.

In view of above, it is therefore requested to use the digilocker for uploading the academic and other certificates/Diploma/ DMCs/ Degree etc. (atleast previous ten years) as an intervention for facilitation of online verification of ibid documents required for ascertaining eligibility criteria in Centrally Sponsored Scholarship Scheme as per the directions received from the Government of India, failing which students may be deprived of scholarships under various Centrally Sponsored Scholarship Schemes from the next Academic Year 2024-25.

This may be given top priority please.
