Sir/Madam,

Your kind intention is invited in reference to the subject cited above as follows:-

### A. Centrally Sponsored Scholarship Schemes.

## Steps to be taken for effective implementation of scholarship schemes.

- Head of Institutions are required to peruse the scholarship scheme guidelines and constitute a
  scholarship committee by including three faculty members and one office staff familiar with the
  use of ICT.
- 2. The Head of Institution shall brief the scholarship committee about the scholarship schemes, guidelines and steps to be taken for effective implementation of schemes and timely disbursal of scholarship to beneficiaries. Scholarship committee shall have key role in "Student Facilitation Centre". Further, Head of Institution shall review the progress of registration of eligible students on National Scholarship Portal and verification of scholarship applications from time to time.
- 3. Students shall be made aware of various scholarship scheme through display boards, classroom campaign, prospectus, website, print and electronic media. Scholarship Scheme can be widely publicized in SMC/PTA, Gram Panchayat / local bodies' general house and through orientation of students at the commencement of academic session.
- Prepare the list of potential beneficiaries for each scheme as per annual income criteria and category of students.
- 5. Potential beneficiaries shall be instructed to procure income certificate, caste certificate from competent authority (SDM, Tehsildar, Naib Tehsildar) well in advance before the opening of National Scholarship Portal.
- The students name and other particulars in all documents such as academic certificates, income
  certificate, caste certificate, bank passbook, Aadhaar Card, Scholarship applications should be as per
  matriculation certificate.

- 7. Bank particulars such as bank account number, name of bank branch, IFSC Code should be got verified from the concerned bank branch. Name of bank should be as per official name. Use of abbreviations and not writing full name result in mismatch and payment failure. Bank account of applicant must be Aadhaar seeded. If student is having multiple bank account numbers, students are required to write Latest Aadhaar seeded bank account only. Bank account should be enabled for DBT and should not be closed/inactive/blocked.
- 8. The students, particularly of **Post Matric Scholarship Scheme** should fillup their online scholarship form on National Scholarship Portal by themselves with utmost care. In case of any difficulty, guidance of scholarship committee or tutor can be taken. Before submitting the scholarship form on Portal, it must be ensured that all **particulars are correct** and **documents** uploaded are **legible**, **relevant and of required size (KB)**. For any lapse, applicants and concerned institutions will be held responsible.
- 9. The applicants are required to note down application number, users login ID and Password for future reference for tracking status of their scholarship application and uploading of required document if it is defected for rectification of wrong bank details or uploading of required document(s).
- 10. The students must not change their registered mobile number and Aadhaar Number. However, in unavoidable circumstances, update your mobile number on National Scholarship Portal and Aadhaar, immediately. Scholarship application if defected by the State Nodal Officer (scholarship) for necessary action if remains unattended by applicants /Institution shall deemed to be rejected. Similarly, if applicant does not respond to the option given to him for correction of bank detail within stipulated period, he will forfeited his claims for scholarship.
- 11. The students should not feel complacent with the submission of scholarship form rather they should respond immediately, if their scholarships application is defected or during payment discrepancy is found in his/her bank details. For this, student gets message on his registered mobile numbers for necessary action on his part within prescribed timeline.
- 12. The scholarship committee must ensure that the scholarship application have been filled up by the applicant as per concerned scholarship scheme **guidelines**, all the required documents have been uploaded and scholarship has been claimed as admissible as per schemes guidelines, Only amounts charged as **non-refundable fees** and **academic /maintenance allowance** are admissible. No fund is to be claimed for scholarship.
- Group and course wise capping details for scholarship under the Post Matric Scholarship Schemes belonging to Scheduled Caste and Scheduled Tribe are as follows.
  - Group –I, For Day Scholars ₹ 80,000/- and for Hostellers ₹ 1,00,000/-
  - Group –II, For Day Scholars ₹70,000/- and for Hostellers ₹ 90,000/-
  - Group –III, For Day Scholars ₹ 45,000/- and for Hostellers ₹ 65,000/-
  - Group –IV, For Day Scholars ₹ 30,000/- and for Hostellers ₹ 50,000/-

Note:- Students who pursue their studies through correspondence courses and term correspondence includes distance and continuing education for Scholarship capping of upper limit is ₹ 20,000/- if a student claim less amount, actual amount will be paid to the student which has to be paid for Institutions/Boards/ Universitie's as per the guidelines of the Schemes for SC/ST/OBC Students.

- 14. The Head of Institution must ensure that scholarship has been claimed as admissible under concerned scholarship scheme guidelines. If any discrepancy is found, of excess payment or under payment recovery will be held from Head of Institutions and scholarship committee.
  No eligible student enrolled in the Institution should be left without scholarship.
- 15. The Head of Institution should conduct **random checking** of at least 10 % scholarship applications to ensure **accuracy** before scholarship applications are verified at Level 1 i.e. Institutional Level.
- In order to ensure timely payment of scholarship to beneficiaries, each Institution is required to ensure the online filling of scholarship application by all eligible students on the day of admission/opening of National Scholarship Portal whichever is later and Institution label verification within 15 days after opening of scholarship Portal. Kindly focus on the opening date of National Scholarship Portal and not on last date. Each Institution must plan appropriately and facilitate for timely disbursal of scholarship to the beneficiaries.
- 17. If applicant discontinue his/her studies and it is found that he /she is not eligible for scholarship for any reasons as per eligibility conditions of concerned scheme guidelines, intimated the Department of Higher Education immediately. A student can opt only one scholarship scheme advantageous to him.

  uploaded on official website of Directorate of Higher Education, H.P.
- As per Merit lists uploaded on DHE websites, filling up of scholarship applications by the
  concerned applicants on NSP and verification at Institutional level is required. The institutional
  Head must ensure that no eligible student is left in his/ her Institutions without scholarship. All the
  particulars and bank details must be correct. Bank account of applicant should be Aadhaar
  seeded.

# **Checklist for Centrally Sponsored Scholarship Schemes**

- 7. Name and other particulars in all documents as per Matriculation Certificate of applicant.
- 8. Fee claim (Tuition fee, Examination fee, admission fee etc) is genuine. No fund has been claimed.

- 9. The applicant has been intimated that he is required to attend classes regularly and should be serious about his study and more than 75% attendance is mandatory during the academic year.
- If applicant has discontinued his study without appearing in annual/semesters examination, matter must be reported to the Directorate of Higher Education, immediately.
- 11. If application is defected or bank details are wrong, needful be done immediately.
- 12. Website of Department of Higher Education is regularly browsed to keep update about instructions regarding scholarship.
- 13. Institution is recognized by competent regulatory body and have a valid UDISE/AISHE/NCVT/SCVT code. Admission of applicant is merit based as per seats allocated to the Institution and fee has been fixed by competent fee regulation committee/Central or State Government.
