Minutes of the meeting regarding observance of State Level "International Day against Drug Abuse and Illicit Trafficking" to be celebrated on 26th June and weeklong pre-International day activities convened under the Chairmanship of worthy Secretary (SJ&E) on 14th June, 2023 at 11:00 AM in his Office Chamber.

List of the officers / officials, who represented stakeholder departments are enclosed as Annexure "A"

- 1. At the outset the Director, Department of Empowerment of SCs, OBCs, Minorities and Specially abled (ESOMSA), Himachal Pradesh welcomed all the participants present in the meeting. He briefly outlined action plan for pre- international day activities as well as the activities proposed for 26th June, 2023 to be undertaken by the various stakeholder departments.
- 2. The Secretary(SJ&E) to the Govt. of HP said that the International day against Drug Abuse and Illicit Trafficking is celebrated on 26th June every year to strengthen actions of the Government and intended to achieve universal goals of a world free of drug abuse.
- 3. He further said that to make the event successful, all departments need to cooperate with the Nodal department as per the programme and activities chalked out by Directorate of ESOMSA. He requested all stakeholder departments to spread the message of drug abuse and illicit trafficking of drugs by involving PRIs, Panchayat Secretaries, Anganwadi workers, NGOs and ASHA workers at Panchayat / village level by exploring all means of communications including social media platforms. This task is to be achieved by active involvement of Deputy Commissioners at District / Field level District Welfare Officers, being Nodal Officers at District level will be coordinating the activities.
- 4. The Chair stressed to focus on border areas of the State, which are more prone to the drug trafficking and abuse including Nalagarh, Baddi areas of Solan District, Fatehpur and Indora areas of the Kangra District and also other areas bordering neighbouring states.
- 5. Action plan as submitted by Directorate of ESOMSA was thoroughly discussed and deliberated upon and following directions were issued:-

A. PRE-INTERNATIONAL DAY CELEBRATION

1. Seven day long extensive opioid plant/cannabis eradication activity upto panchayat level will commence from 19th June, 2023 under the overall supervision of concerned Deputy Commissioners and Superintendent of Police involving District Programme Officer and

- 2. The Department of Public Relation, Social Justice & Empowerment, YSS, Education, Health and all Deputy Commissioner and Superintendents of Police shall promote hash-tag # "Nasha Mukta Himachal" on their social media platform and the Deptt. of Social Social Justice & Empowerment shall display hoardings (IEC) at District/Tehsil level.
- 3. All the schools, colleges, ITI, Polytechnic shall conduct declamation, Quiz competition, painting competition, awareness rallies between 19th to 25th june on the theme of "Anti Drug and Illicit Trafficking" and "Nashu Mukt Himachal". -Action by- ESOMSA, DC, Shimla, YSS, Home Department / Police.




2. Main Event:
