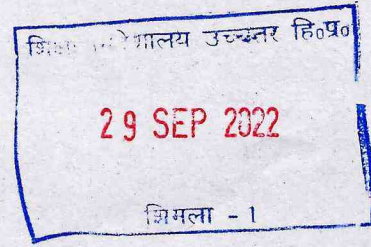




OFFICE ORDER


