ORDER

No. EDN-B-B(6)-21/2023-L-1

Dated: Shimla-2, the 05-10-2023.


1.. Whereas Kamal Singh Pathania, Principal, was transferred from GSSS Patlandhar, Distt. Hamirpur to GSSS Basadhar, Distt. Shimla and he challenged these orders before the Hon'ble High Court vide CWP No. 6123 of 2023 with the grievance that his remaining service is less than two years and he was having short stay at his place of posting and that he has health issues and he should not be transferred on medical grounds. The Hon'ble High Court on dated 05.09.2023 decided that matter and the operational part of the judgement is as under:-

"In view of the above submissions, this writ petition is disposed of by permitting the petitioner to make a representation to respondent No.1/competent authority within two days from today, which shall be considered and decided by respondent No. 1/competent authority, within a period of one week thereafter with due regard to the difficulties being faced by the petitioner."

2. Whereas, as per the directions of Hon'ble High Court and the representation of the petitioner, he was afforded an opportunity of being heard in person on 25.09.2023. During the hearing the petitioner submitted that he is on the verge of retirement as a period of less than two years is left for his retirement so he may be adjusted within his native district or at a nearby place. He further submitted that his family circumstances are adverse and he has undergone a major surgery recently. He submitted that his father is suffering from cancer and his wife is a depression patient. He requested to adjust him at suitable place in/around Hamirpur..
3. Whereas, from the perusal of service record of the petitioner it has been found that the petitioner has spent most of his service tenure within Hamirpur District.


