Whereas, Smt. Kanta Devi, Principal, was transferred from GSSS Phagoo, Distt. Sirmour to GSSS Basahan, Distt. Sirmour and she had challenged these transfer orders before the Hon'ble High Court vide CWP No. 2299 of 2024. The Hon'ble High Court on dated 20.03.2024 decided the matter and passed following order:-

*“ After making her submission for some time and after finding that the Court is not with the Petitioner in view of the fact that the petitioner has already completed normal tenure, learned counsel for the petitioner submits that the petitioner be permitted to withdraw the petition, but with liberty to approach the respondents for her adjustment at some other station which are lying vacant.*


*The Petitioner is permitted to be withdrawn, with liberty as prayed for. In the event of any such representation being made by the petitioner, the same be considered sympathetically and if possible, the petitioner be adjusted in some other station.*

*Pending miscellaneous applications(s), if any also stand disposed of accordingly.”*

Whereas, the petitioner submitted a representation requesting therein to transfer her to GMSSS Rajgarh, Distt. Sirmour considering the fact that her husband is also working as Principal at GSSS Dahan, Distt. Sirmour, which is near Rajgarh and they will be able to stay at one place.



Now therefore, the undersigned after considering facts and circumstances of the case and after taking into account the couple case that she may be posted as Principal, Govt. Model Senior Secondary School, Rajgarh, Distt. Sirmour against vacant post.


