Sir/Madam,

To prevent any incident of molestation or sexual abuse of school-children, students and teachers need to be sensitized on issues relating to Good Touch and Bad Touch. The children need to understand and differentiate between a physical touch which makes one uncomfortable and brings in fear and insecurity, from the physical touch which makes one feel secure and happy.

2. As a step in this direction, the Ministry of Women and Child Development commissioned a short animated film called "KOMAL" on this subject and have suggested that it may be used for sensitizing the children as well as institutions. The film is accessible on Youtube in English, Hindi and regional languages, the links to which are enclosed at annexure.

3. You are requested to take steps as appropriate in this regard to make the children aware of Good Touch and Bad Touch and also the avenues they can approach in case they need help.
