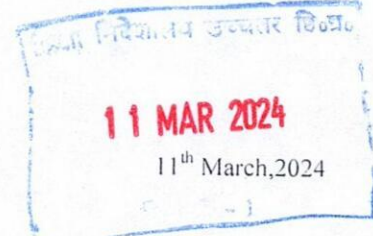



8. No TA/DA is admissible.


