ORDER

Whereas, Sh. Lucky Sharma, Lecturer (Economics) was transferred from GSSS Sera (HMR) to GSSS Surani (KGR) vice Sh. Desh Raj, Lecturer (Economics) vide this office order of even number dated 31.07.2023. Against these orders Sh. Lucky Sharma filed CWP No. 5057/2023 before the Hon'ble Court regarding his suitable adjustment in GSSS Pohanj (HMR) or in any school in District Hamirpur being a couple case and on medical grounds. The case was finally disposed of by the Hon'ble Court on 04.08.2023 with the following directions:-

"In view of the above submission, this writ petition is disposed of by permitting the Petitioner to make a representation to respondent No. 2 within a week from today, which shall be considered and decided by respondent No.2/competent authority in accordance with law and applicable policy, within a period of two weeks thereafter. The decision so arrived at shall be communicated to the petitioner."

And whereas, upon passing of above directions, petitioner, Sh. Lucky Sharma, Lecturer (Economics) submitted a representation and requested to adjust him in GSSS Pohanj (HMR) against vacancy. He has further requested that his wife is also serving as Lecturer History in Distt. Hamirpur. If it is not feasible to adjust him at GSSS Pohanj (HMR) then in the alternative both of us may be adjusted in same place in any school of Distt. Hamirpur.


And whereas, as per the direction passed by the Hon'ble Court as above, the request of the petitioner has been considered and found that at present the post of Lecturer (Economics) is not lying vacant at GSSS Pohanj (HMR) moreover there is no vacancy of Lecturer (Economics) in District Hamirpur and as well as Lecturer (History) where both of them can be adjusted. However, the post of Lecturer (History) is lying vacant at GSSS Ludder-Mahadev (HMR) but the post of Lecturer (Economics) is not sanctioned in the said school.

Now therefore, after taking into account the above discussed detailed facts and circumstances, the request of the petitioner cannot be acceded to. Hence in view of ongoing facts, representation of the petitioner has been considered and rejected and he is further directed to join at GSSS Surani (KGR).

With these observations, representation stands disposed of.
