**ORDER**

Whereas, Smt. Meena Devi, Lecturer (School-New) (Economics) has filed CWP No. 10717/2023 before the Hon'ble High Court regarding her transfer from GSSS Chah ka Dohra, Distt. Mandi to GSSS Jarol (Mandi) against vacancy being caused due to retirement of present incumbent on 31.12.2023 or GSSS (Boys) Sundernagar (Mandi) against vacancy being caused due to retirement of Smt. Anju Sharma on 29.02.2024 as such her son is suffering from Cerebral Palsy. The case was listed before the Hon'ble High Court on 28.12.2023 when the case was disposed of with the following directions:-

"In these circumstances, this court as requested by Mr. Kush Sharma, learned counsel for the petitioner, permits him to make a fresh representation within a week from today; with further directions to Respondents No.-2 Director of Higher Education, Shimla to consider the representation dated 13.08.2022 (Annexure P 2) including fresh representation and to pass appropriate order(s), within two weeks thereafter."

And whereas, upon passing of above directions, petitioner, Smt. Meena Devi, Lecturer (School-New) Economics has submitted a fresh representation and requested to adjust her at choice of stations i.e. GSSS Jarol (Mandi) against vacancy being caused due to retirement of present incumbent on 31.12.2023 or GSSS (Boys) Sundernagar (Mandi) against vacancy being caused due to retirement of Smt. Anju Sharma on 29.02.2024 keeping in view of medical problems of her son.

And whereas, as per the direction passed by the Hon'ble High Court as above, the request of the petitioner has been considered and found that post of Economics is not lying vacant at GSSS Jarol (Mandi). However, post of Economics is going to vacant at GSSS (Boys) Sundernagar (Mandi) on 29.02.2024 but it is not feasible to adjust her at GSSS (Boys) Sundernagar (Mandi) at this early stage.

Now therefore, after taking into account the above discussed detailed facts and circumstances, the request of the petitioner cannot be acceded to. Hence in view of ongoing facts, representation of the petitioner has been considered and rejected.

With these observations, representation stands disposed of.
