Sir,

Your kind attention is drawn towards this Directorate letter of even No. dated 22-10-2021 followed with reminder letters dated 16-11-2021 & 09-12-2021 vide which you were requested to register all schools where food is served to the eligible school students under PM Poshan under the provisions of Food Safety & Standard Act-2006 in a time bound manner through on-line Portal foscoss.fssai.gov.in for which fee of Rs 100/- per school will be charged. In this context you may take the help of Assistant Commissioners (Food Safety) at district level. It was also decided in the 3rd State Level Advisory Committee meeting held on 29-09-2021 para (J) of the minutes, that every school also adopt Safe & Nutritious food @ school(SNF @School) initiative through on-line Portal www.snfportal.in. The objective of this initiative is to create continuous engagements with the school students, teachers & parents to make them aware about the importance of Safe & Nutritious food. This can be done through curricular or co-curricular activities. However, the culture of Food Safety & Nutrition is to be promoted through Health and wellness Coordinators and Health teams at School Level.

In view of the above, you are once again requested to ensure the registration of all schools where food is served to the eligible school students under PM Poshan under the provisions of Food Safety & Standard Act-2006 in a time bound manner through on-line Portal foscoss.fssai.gov.in and furnish the detail/Status in this regard to this Directorate.

This may be treated as most urgent, time bound & be given top priority and personal attention in the matter please.

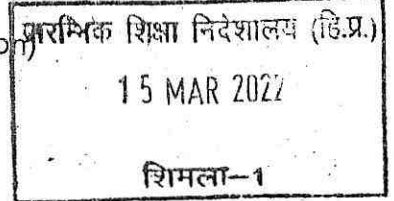

Resuming of regular hot cooked meal to all the eligible school students under Pradhan Mantri Poshan Shakti Nirman (PM Poshan) earlier known as Mid Day Meal Scheme.

Sir

Your kind attention is drawn towards this Directorate letter of even No. dated 19-02-2022 followed with reminder letter dated 26.02.2022 vide which you were directed to resume the regular hot cooked meal to the eligible school students under Pradhan Mantri Poshan Shakti Nirman (PM Poshan) earlier known as Mid Day Meal Scheme w.e.f 1st March, 2022, by following all standard operating procedures (SOP's) / protocols / guidelines / instructions issued by the Government from time to time.

In view of the above, you are requested to direct all the BEEO's / Schools to ensure the distribution of prescribed per child per school working day Food Security Allowance (FSA) i.e. foodgrains(rice)@100 gms per Primary and @150 gms for Upper Primary students excluding vacation period and cooking cost @Rs.4.97 for Primary and @7.45 for Upper Primary students respectively (or its equivalent pulses, oil etc.) to the eligible school students under abovesaid Scheme for the closure period of schools including vacation period due to lockdown / curfew in view of Covid-19 pandemic upto 28.02.2022 during F/Y 2021-22 in lieu of hot cooked meal and it may be ensured that none of the eligible students are left without distribution of aforesaid prescribed FSA in lieu of hot cooked mid day meal for the closure period of schools upto

28.02.2022 under PM Poshan Scheme in all winter and summer closing schools in the State during F/Y 2021-22.
